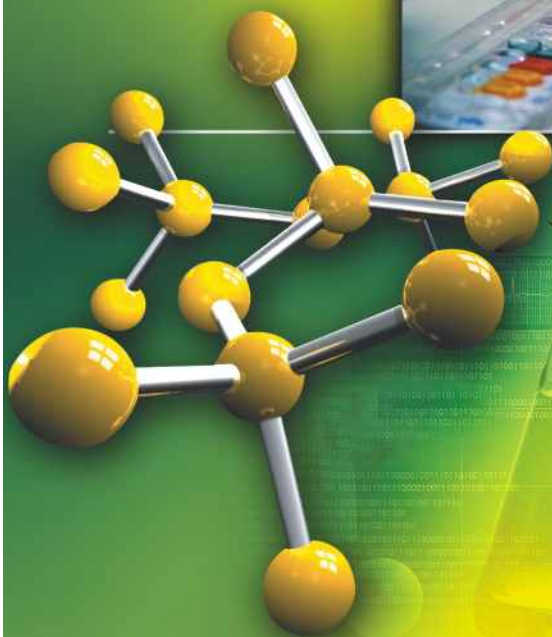
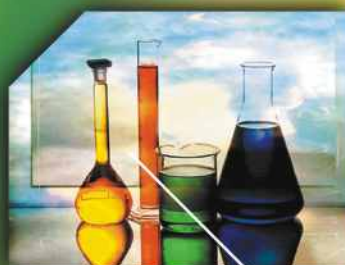

C V RAMAN INTERNATIONAL FELLOWSHIP FOR AFRICAN RESEARCHERS FOR RESEARCH IN INDIA- 2010

The Fellowship provides opportunities for African researchers to conduct collaborative research / training for 1 to 12 months duration at universities and research institutions in India.

FEATURES:

- Supporting upto one year of research work in India in area of science and technology
- Monthly sustenance allowances
- Additional contingency grant
- To and fro air fare by economy class
- Total of 8 fellowships per country, totaling to approximately 416 fellowships

APPLICATION DEADLINE : 31st May 2010

TYPES AND NUMBER OF FELLOWSHIPS OFFERED :

Each African country will have 8 slots of fellowship totaling approximately 416 fellowships under this programme.

(a) **Post Doctoral Fellowship** : Duration 6 months. Maximum 2 fellowships of 6 months duration each or one fellowship thereof subject to total 12 man-months.

(b) **Visiting Fellowship** : Duration 3 months. Maximum 3 fellowships

(c) **Senior Fellowship** : Duration 1 month. Maximum 3 fellowships

ELIGIBILITY:

The applicant should be actively engaged in research at a university or research institution in the African country and should meet the following eligibility criteria for each of the three categories :

- (a) Post Doctoral Fellowship : Ph.D
- (b) Visiting Fellowship : Ph.D/M.Tech or 6 to 10 years working experience
- (c) Senior Fellowship : Senior Experts/Scientists/Professors

VALUE OF AWARD:

- (a) Sustenance Allowance:
 - (i) Post Doctoral Fellowship : Rs.40,000/- per month including accommodation
 - (ii) Visiting Fellowship : Rs.50,000/- per month including accommodation
 - (iii) Senior Fellowship : Rs.50,000/- per month + accommodation
- (b) Contingency : Rs.10,000/- to Rs.20,000/-
- (c) Air fare: A round trip air ticket by economy class
(Approximate conversion rate US \$ 1= Rs 45)

HOW TO APPLY:

Federation of Indian Chambers of Commerce & Industry (FICCI) is the Coordinating Partner for C V Raman International Fellowship Programme. Application of the candidates should be sent to FICCI through designated nominating authority in their respective countries, with a copy to the respective Indian Mission.

The application should reach FICCI before 31st May, 2010.
